ENTRY GUIDE:

This award is open to any staff member of a Financial Services Federation member company with less than five years' experience in the sector who has thoroughly embraced the concept of responsible lending, leasing, or the responsible provision of credit-related insurance throughout the course of the last year (or more).

The nomination form for this category must be completed in full and provided to the Financial Services Federation together with:

- 1. Two examples of where the person nominated has gone above and beyond what is required of them to ensure a mutually beneficial solution for customers and/or to demonstrate a high standard of responsible lending, leasing, or provision of credit-related insurance products. Examples may be anonymised.**
- 2. A brief (no more than 500 words) statement from the person being nominated as to what responsible lending or leasing behaviour (or the provision of credit-related insurance products) means to them and how they espouse this in their customer**

interactions. If the person has been nominated by someone else, the person who nominated them may instead provide 500 words stating why they believe the nominee is deserving of the award based on the principles mentioned above.

3. A brief (no more than 250 words) statement from the person being nominated (or their nominator) as to what the nominee plans for the next 12 months and beyond to upskill themselves (or others) in what it means to be a responsible lender or credit-related insurance provider.

QUICK TIPS FOR YOUR ENTRY

- Remember this is a document to showcase your dedication to responsible lending. Tell us your story, be proud, and don't skip on the details.
- Where possible, include examples, project milestones, case studies, key performance data or testimonials.
- Include where appropriate, charts, simple stats, graphics, photos or other visual devices that might illustrate points in your entry.

TERMS & CONDITIONS

- Award nominations/entries are only available to members of the FSF or individuals who belong to member companies of the FSF. Finalists are encouraged to attend the awards in person where possible, where the winner will be announced.
- Prizes are in New Zealand dollars and are to be used in good faith by the winner towards the cost of further professional development.
- Finalists will be asked to supply FSF with a photo which may be used for internal and external marketing/media/communications purposes before and/or after the awards. Finalists may be required to participate in some media/marketing activity such as an interview or Q&A.
- The winner will be photographed with the award sponsors and FSF Executive Director directly after receiving their award.
- Those nominating someone else must gain permission from the person they are nominating.
- Upon hitting "Submit", the person nominating or entering declares that all content in their Entry Document is true and correct to the best of knowledge at the time of entering.
- Nominations can be self-made or made by a colleague, supporter or employer, but all entries are to be endorsed by the employer or appropriate management team member.
